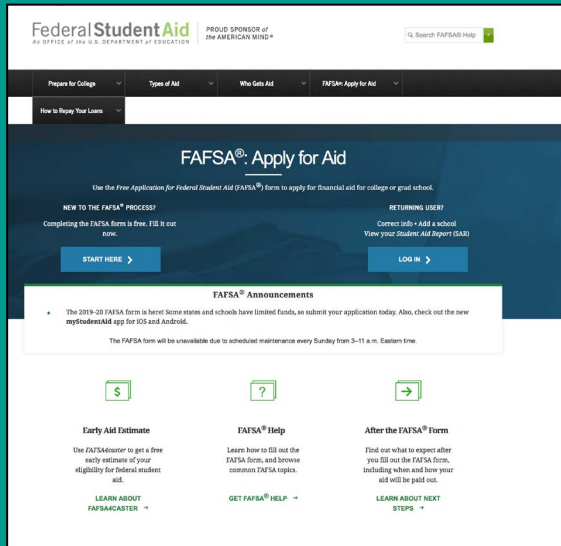

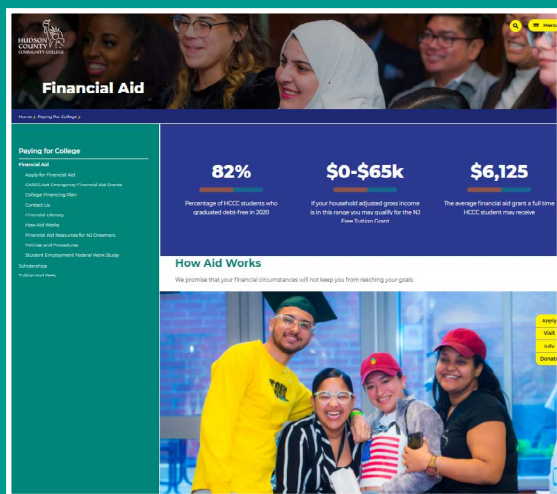

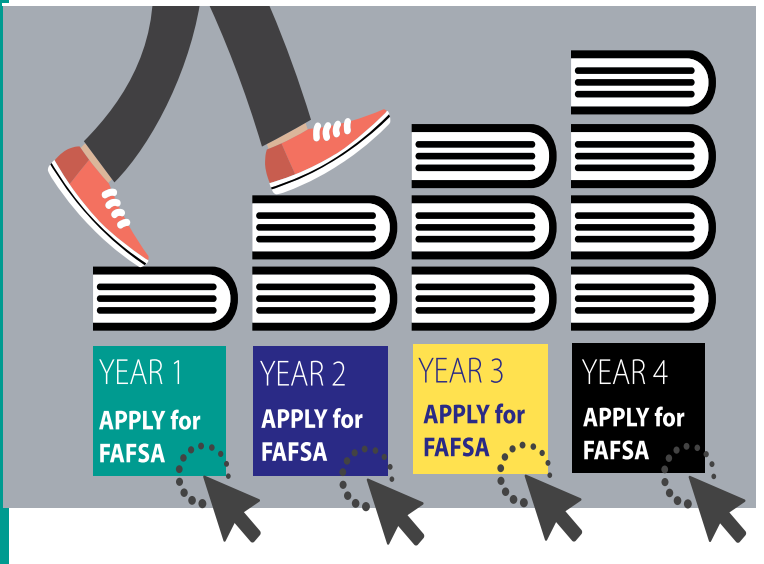

Available Now Every Fall and Spring Semester!

Community College Opportunity Grants (CCOG) are awards that will pay the costs of tuition and approved educational fees not already covered by other available grants applied to the student’s account for New Jersey residents with an annual adjusted gross income (AGI) between \$0 and \$65,000. For New Jersey residents with AGIs between \$65,001 and \$80,000, CCOG will pay up to one half of the cost of tuition at the college. For New Jersey residents with AGIs between \$80,001 and \$100,000, CCOG will pay up to one third of the cost of tuition at the college.

Who is eligible for tuition-free Community College:
Community College Opportunity Grants are available to students who meet the following eligibility requirements:




- Be a New Jersey resident with a total household adjusted gross income between \$0 - \$100,000
- Complete the FAFSA or NJ Alternative Financial Aid Application by applicable state deadlines
- Enroll in at least six (6) credits per semester at HCCC.
- Have no prior college degree
- Make satisfactory academic progress

FEDERAL STUDENT LOAN PROGRAMS

What is a Federal Student Loan?

Federal loans are borrowed funds that you must repay with interest. A federal loan allows students and their parents to borrow money to help pay for college through loan programs supported by the federal government. They have low interest rates and offer flexible repayment terms, benefits, and options.

What types of Federal Student Loans are available?

The U.S. Department of Education offers the William D. Ford Federal Direct Loan Program. It is the largest federal student loan program. Hudson County Community College participates in Direct Subsidized Loans, Direct Unsubsidized Loans, and Direct PLUS Loans programs.

To apply for a student loan, you must complete the steps below:

1. Create your own personal FSA ID at studentaid.gov
2. Complete and submit a FAFSA at studentaid.gov



ARE YOU READY TO APPLY FOR A FEDERAL STUDENT LOAN?

Go to studentaid.gov and follow these four easy steps:

1. Log in with your FSA ID.
2. Complete and sign a Master Promissory Note (MPN), agreeing to the terms of the loan.
3. Complete and sign the entrance counseling, a tool to ensure you understand your obligation to repay the loan.
4. Complete the loan request form obtained on the Financial Aid website, <https://www.hccc.edu/paying-for-college/financial-aid/federal-verification.html> and submit to the Financial Aid Office.

When completing exit counseling, please be sure to do the following:

- Do not let your session time out while you're completing the counseling. Sessions time out after 15 minutes of inactivity.

To Access Exit Counseling:

- Login with your FSA ID at I am an Undergraduate Student

You will need to proceed through the counseling in the order below. You must finish exit counseling in one sitting.

Throughout the counseling, you will answer a few questions to help you remember what you have learned.

Topics include:

Contact Settings – confirm contact information, references, notify schools, and why am I completing exit counseling

My Loans – learn what do I owe, loan terminology, when do I pay, what is interest accrual, and what is interest capitalization and when does it occur?

Preparing to Repay – learn who's responsible for what in your student loan journey, your loan servicer, understanding student loan obligations, federal student loan benefits and options, what happens if you default?

Determine Your Repayment Strategy – learn family details, employment plans, salary information, repayment goal, repayment strategy.

1. GO TO SELF -SERVICE FINANCIAL AID

2.) REVIEW YOUR CHECKLIST AND LIST OF RESOURCES

To view the current status of your financial aid by year, select an academic year from the "Select an Award Year." Scroll down and you will find both the checklist and list of resources.



3.) VIEW YOUR MISSING DOCUMENTS

If you have missing documents, click the "complete required documents" to view the list of required documents for a specific academic year, as well as their status (i.e. received, incomplete).



4.) VERIFY IF YOU ARE MEETING THE SATISFACTORY ACADEMIC PROGRESS

The Self-Service displays your most current financial aid Satisfactory Academic Progress (SAP) status. If you are not in good standing, you will receive an email notification from the financial aid office. You may also email your financial aid counselor if you need further assistance.

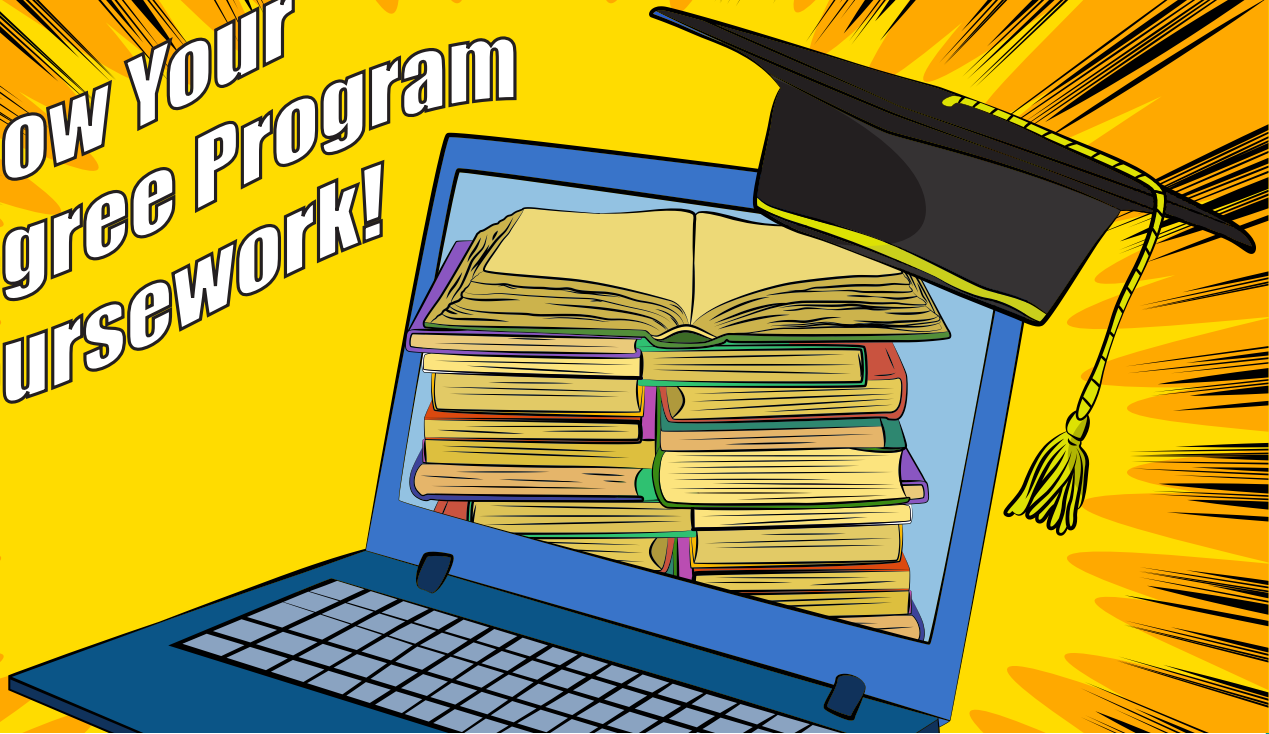

Know Your Degree Program Coursework!



Do you know why it is important to register for courses in your degree program?

Understand what happens if you enroll in non-required courses!

Maximize your financial aid funding by following the federal regulations for degree course completion and funding.

- Receive federal Title IV funding for all your coursework that count towards completing your degree program requirements
- Fulfill major and general elective requirements for Title IV funding
- Know that you will not receive federal Title IV funding when you enroll in **non-required coursework** (courses that do not apply to your degree program)
- Keep track of your academic progress and courses by going to Student Planning Self-Service: Student Planning My Progress

Recommendations:

- Consult with your Academic Advisor to verify your current semester course enrollment
- Make sure all coursework is part of your degree program
- Contact your Financial Aid Advisor to verify your funding and any additional questions on federal regulations
- Regularly check your email for any additional notifications

FINANCIAL AID TECHNOLOGY INFORMATION

The Self-Service Financial Aid guides you through the Financial Aid process using a web-based process and interactive checklist through easy access from a desktop or mobile device. You can view each step of the application process with clear instructions on documentation.

- **Account Summary** — view a summary of your account which includes amount over due, total amount due, make a payment, and total account balance (any activity)
- **Award Letter** — complete the electronic signature or print and deliver to the Financial Aid Office
- **College Financing Plan** - shopping sheet
- **Correspondence Option** — you can choose to receive hard copies of Financial Aid correspondence
- **Outside Awards** — you can report new or view existing awards received from outside sources
- **Required Financial Aid Documents** — list of missing documents. Submit before their due date to make sure your Financial Aid package is not delayed
- **Satisfactory Academic Progress** — you can view your SAP for an evaluation period
- **Your Awards** — you can accept or decline awards and update your loan amounts

Steps for how to use E Signature Forms

BENEFITS OF E-SIGNING YOUR FINANCIAL AID FORMS:

REQUESTING A FREE IRS TAX RETURN TRANSCRIPT

If you need to request a tax return transcript from the IRS, follow one of the methods below to easily obtain one.

Please make sure you request a Tax Return Transcript, and not a Tax Account Transcript or Record of Account, for financial aid verification purposes.

Here are three easy ways to obtain your Tax Return Transcript:

ONLINE REQUEST

OPTION 1

- Visit www.irs.gov
- Select "Get your Tax Record". Select "Get transcript Online and Click "Create a new account." If you have an existing IRS username, please create a new ID.me account as soon as possible. If you are a new user, please create an account with ID.me.
- The user must have access to valid email address and a tax enable mobile phone (pay as you go plans cannot be used) in the user's name. Please be sure to use your personal email address when creating the account.
- A link will be sent to your email address for verification.
- Choose from the various options to secure your account. (Text message or phone call, Push notification to ID.me authentication mobile app, Code generator application or NFC-Enabled Mobile security key)
- To verify your identity with ID.me, you will need to provide a photo of an identity document such as a driver's license, state ID, or passport. You will also need to take a selfie or video chat with a smartphone or a computer with a webcam. If you need help verifying your identity or to submit a support ticket, you can visit the ID.me IRS Help Site
- Enter the requested information and click continue.
- The transcripts display online upon successful of the IRS's two – step authentication.
- Select "Return Transcript" for the type of Transcript.
- Select the tax year requested and click continue.

OPTION 2

- Get Transcript By Mail
- Enter Requested information and click continue
- Select Return Transcript
- If successfully validated, tax filers can expect to receive a paper IRS Return Transcript at the address on file with the IRS within 5 to 10 business days.

TELEPHONE REQUEST

- Call the IRS at 1-800-908-9946
- Enter your Social Security Number or the first person listed on a joint tax return and confirm it.
- Verify address listed on the tax return using only the digits.
(For example, if your address is 221 Main Street, enter only 221; confirm address)
- Select tax information type to receive – Option 2 a copy of your Federal Income Tax Return Transcript
- Indicate the year that you would like to receive the information for example (2016) and confirm the year
- If successfully validated, tax filers can expect to receive a paper copy at the address on file with the IRS within 5 to 10 business days.
- IRS Tax Return Transcripts cannot be sent to an address other than the one on file with the IRS

VISIT A LOCAL IRS OFFICE

- If online and telephone requests are not available because of address changes or other errors, please visit a local IRS office to address the problem.
- Locate an IRS office through <https://www.irs.gov/>
- Be aware that some IRS offices require that you schedule an appointment and some have limited services. Check with your IRS office that they provide the tax transcript service.
- Bring a form of photo identification (driver's license).
- Request a Tax Return Transcript.
Note that some offices may not have printing services
- The nearest IRS office to Hudson County Community College is located in Newark at 20 Washington Place. The hours of operation are Monday through Friday, 8:30 a.m. - 4:30 p.m. You can contact them via phone at (973) 645-5543
- Allow 5 to 10 business days to receive your Tax Return Transcript.
- Keep a copy of your Tax Return Transcript for your record before you submit it.
- If requesting by mail, the Tax Return Transcript prints on both sides; make sure to copy both sides.
- When requesting the IRS Federal Tax Return Transcript, please remember that it is the Tax Return Transcript and NOT the Account Transcript.

Do you know what **SAP** or satisfactory academic progress is?

SAP is a set of academic progress standards students must meet before receiving financial aid. Both federal and state funding will be compromised.

What to do to maintain financial aid eligibility if you are not making SAP (satisfactory academic progress).

Here's how in four easy steps:

1 Complete the SAP appeal form within the first two weeks of the semester you are enrolled in at <https://www.hccc.edu/paying-for-college/financial-aid/federal-verification.html> (Scroll to the current FAFSA award year)

2 Be sure to explain the extenuating circumstances that lead to you not progressing academically. Include changes or resources you will use to ensure your future academic success.

For maximum time frame appeals, explain why you have not completed your degree program within 150% of the required credit hours for your current degree program.

3 Gather date-specific documentation to support your circumstances, including medical records, paycheck stubs, transcripts, death certificates, or accident reports.

4 Appeals are reviewed in the order received as long as supporting documentation is attached to your request. If approved, your next step is to meet with your academic advisor and complete an academic plan by discussing strategies for your success.



FAILURE TO APPEAL/APPEAL DENIED

You are ineligible for both federal and state financial aid. You must seek alternative enrollment options and sources of funding!

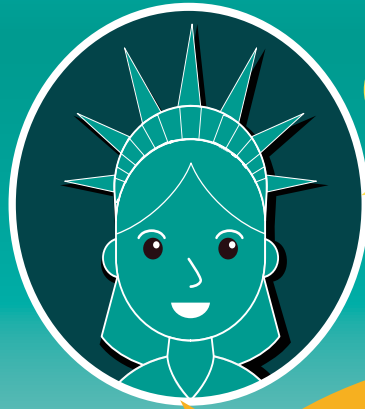

New Jersey Voter Registration Information

**Democracy is not a spectator sport. It requires continual work to protect it and keep it strong.
The best way to protect and strengthen our democracy is to participate in it!**

You are entering a new phase of your lives where you will have even more influence in what happens in your local community, the state and the country. As a citizen, your active civic participation as a voter is essential in that process. The first step in that process is to register to vote.

To register in New Jersey, you must be:

- A U.S. citizen
- At least 17 years old, though you may not vote until you have reached the age of 18
- A resident of the county for 30 days before the election
- You are not serving a sentence of Incarceration as a result of a conviction of an indictable offense under the laws of this or another state or of the United States.
