VII. APPOINTMENT OF COUNSEL TO HUDSON COUNTY COMMUNITY COLLEGE FOR 2020-21

1. Resolution Authorizing Renewal of Real Estate Counsel Services for Fiscal Year 2021

WHEREAS, Hudson County Community College ("College") requires real estate counsel services; and,

WHEREAS, pursuant to N.J.S.A. 18A:64A-25.5 (a) (1), this service is exempt from public bidding as it is a professional service; and,

WHEREAS, the anticipated term is until October 31, 2021; and,

WHEREAS, John Curley, LLC submitted a proposal to provide these services at a rate of \$150 per hour, which represents no increase from the prior year; and,

WHEREAS, the College has determined that the proposal submitted by John Curley, LLC is in the College's best interests; and,

WHEREAS, the cost of these services will be funded from the operating budget; and,

WHEREAS, the Administration and Finance Committee recommend this award;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Hudson County Community College award a contract for real estate legal counsel services to John Curley, LLC of Jersey City, New Jersey, in accordance with the terms of the proposal submitted by the law firm.

BE IT FURTHER RESOLVED that the Board of Trustees authorize the Administration to take all steps necessary to effectuate the terms of this resolution.

2. Resolution Authorizing Renewal of General Legal Counsel Services for Fiscal Year 2021

WHEREAS, Hudson County Community College ("College") requires general legal counsel services; and,

WHEREAS, pursuant to N.J.S.A. 18A:64A-25.5 (a) (1), this service is exempt from public bidding as it is a professional service; and,

WHEREAS, the College conducted a fair and open process to solicit proposals for the services; and,

WHEREAS, the anticipated term is until October 31, 2021; and,

WHEREAS, Scarinci Hollenbeck, LLC ("SH") submitted a proposal to provide the services at the rate of \$185 per hour, which represents no increase from the prior year; and,

WHEREAS, the College has determined that the proposal submitted by SH is in the College's best interest; and,

WHEREAS, the cost of these services will be funded from the operating budget; and,

WHEREAS, the Administration and Finance Committee recommend this award;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Hudson County Community College award a contract for general legal counsel services to Scarinci Hollenbeck, LLC of Lyndhurst, New Jersey, in accordance with the terms of the proposal submitted by the law firm.

BE IT FURTHER RESOLVED that the Board of Trustees authorize the Administration to take all steps necessary to effectuate the terms of this resolution.
