NOTICE TO BIDDERS : INVITATION TO BID

Notice is hereby given that sealed Bids will be received by the Hudson County Community College ("College"), Hudson County, New Jersey, at or before **11:00 A.M. prevailing time on January 12**, **2024**, at the offices of Jeff Roberson, Jr., Director of Contracts and Procurement, 26 Journal Square, 14th Floor, Jersey City, NJ 07036 for the Hudson County Community College Mixed-Use Academic Building, Jersey City, Hudson County, New Jersey, at which time and place all Bids will be unsealed immediately, the contents thereof will be publicly announced and a proper record of the prices and terms will be made.

Bid documents for the Project, including but not limited to, Bid Specification and Plans will be available by download from an email link upon request and registration with the Architect as a potential Bidder. Bids must be enclosed in sealed envelopes endorsed: **<u>BID PACKAGE: Hudson County</u>** <u>**Community College Mixed-Use Academic Building, Jersey City, Hudson County, New Jersey,** and delivered to the Director of Contracts and Procurement between the hours 9:00 A.M. and 4:00 P.M. on official business days at or before the opening of Bids at 11:00 a.m. **on January 12, 2024**. No Bid will be received thereafter. Bids must be submitted on the applicable proposal forms in the manner designated.</u>

Each Bid must be accompanied by: (1) cashier's check, certified check or Bid bond payable to "Hudson County Community College" in the sum <u>equal to ten percent (10%) of the Bid</u> pursuant to <u>N.J.S.A.</u> 18A:64A-25.16, (2) a certification by surety and consent of surety from a surety company authorized to do business in New Jersey that such company will provide the Bidder with a Performance Bond and Payment Bond(s) as called for in the Bid Specification pursuant to <u>N.J.S.A.</u> 18A:64A-25.17, (3) Statement of Ownership Disclosure as required by <u>N.J.S.A.</u> 52:25-24.2, and (4) all other forms (signed and notarized as appropriate) required by the Bid Specification which may include, but shall not be limited to, the Bid proposal form, Bid document submission checklist, acknowledgment of receipt of changes to Bid documents, certificate of subcontractor's scope of work, affirmative action certification, certification of Bidder's experience and financial responsibility, non-collusion affidavit, vendor's lobbyist/consultant disclosure statement form, and certification of non-retention of lobbyist/consultant.

The successful Bidder will be required to enter into a <u>Project Labor Agreement ("PLA")</u> pursuant to <u>N.J.S.A.</u> 52:38-1, <u>et seq.</u>, for the contract work in the form provided with the Bid Specification, and the provisions of the PLA shall govern all labor under the contract. All Bidders

must include as part of their Bid a fully executed <u>Acknowledgement Of Project Labor</u> <u>Agreement Required For The Project</u>. In the event that any provision(s) of the PLA should conflict with any of the requirements specified elsewhere in this Notice To Bidders and/or the Bid Specification, the provisions of the PLA shall control.

No contract shall be awarded to a Bidder unless the Bidder has provided proof of compliance with "The Public Works Contractor Registration Act", <u>N.J.S.A.</u> 34:11-56.48, <u>et seq</u>. and Business Registration pursuant to <u>N.J.S.A.</u> 52:32-44, and any contract so awarded is contingent upon conformance with these conditions throughout the course of performance.

It is required that no less than the Prevailing Wage salary rates of pay as provided for by the New Jersey Prevailing Wage Act, <u>N.J.S.A.</u> 34:11-56.25, <u>et seq.</u>, shall be paid for labor under the contract. Bidders are required to comply with the requirements of <u>N.J.S.A.</u> 10:5-31, <u>et seq.</u> and <u>N.J.A.C.</u> 17:27-1.1, <u>et seq.</u>, regarding Equal Employment Opportunity and with the Americans with Disabilities Act of 1990, 42 <u>U.S.C.</u> § 12101, <u>et seq.</u> Attention of Bidders is called to the existence of statutes and regulations relative to the safety of workmen, hours of labor, workman's compensation insurance, preference for and prohibition of certain types of labor and other particular statutes and regulations affecting the proposed public work together with regulations, rules and ordinances of the municipality in which the work is to be done.

As federal funds will be utilized, the Bidder is required to comply with certain required contract provisions for non-federal entity contracts under Federal awards, including, but not limited to, those of Appendix II to 2 <u>C.F.R.</u> Part 200, Davis-Bacon Act (40 <u>U.S.C.</u> 3141, <u>et seq.</u>) and Byrd Anti-Lobbying Amendment (31 <u>U.S.C.</u> 1352). All vendors that receive payments for goods or services with funds received from the Federal Government are required to register with SAM.gov and obtain a Unique Entity Identifier (UEI). (This was formerly known as a DUNS Number.) Please consult SAM.gov for more information or if you have questions about obtaining an UEI. Vendors will be required to provide their UEI number as well as a print out from SAM.gov showing their UEI number.

Once submitted, no Bid can be withdrawn without notice to the College. The College reserves the right to reject all Bids pursuant to applicable law.

Bids may be held by the Hudson County Community College for a period not to exceed sixty (60) days from the date of opening of the Bids for the purpose of reviewing the Bids and investigating the qualifications of the Bidders, unless the Hudson County Community College obtains consent from the Bidders to extend such time.

In the event a prospective Bidder desires clarification of any details or provisions of the Bid Specification or Plans, in order to receive consideration, requests for such clarifications must be made in writing to the College's Director of Contracts and Procurement in time to be received at least ten (10) business days before the scheduled opening of Bids. The College will respond in accordance with N.J.S.A. 18A:64A-25.14(b).

Any prospective Bidder who wishes to challenge a provision of the Bid documents (including the Bid Specification and Plans) shall file such challenge(s) in writing with the College's Director of Contracts and Procurement no less than three (3) business days prior to the opening of the Bids.

Challenges filed after that time shall be considered void and as having no impact on the College or the award of the contract.

There shall be a pre-Bid meeting and site inspection at 81 Sip Avenue, Facilities Conference Room, Jersey City, NJ on **November 13, 2023, at 11:00am.** Attendance by prospective Bidders is encouraged. The acceptance of any Bid and award of a contract by the Hudson County Community College is contingent upon the Chief Financial Officer's certification that the funds are available.
