BAKARI G. LEE, ESQ. RECOGNIZED FOR SERVICE AS NJCCC CHAIR

n Monday, Nov. 17, the New Jersey Council of County Colleges honored outgoing Chairman Bakari G. Lee, Esq. for his three years of service. During his time as NJCCC Chairman, New Jersey's 19 community colleges achieved unprecedented successes, including the implementation of the BIG IDEAS Project, the founding of the New Jersey Center for Student Success, enhanced capital funding through the passage of the Building Our Future Bond Act, the passage of legislation that preserves the New Jersey Student Tuition Assistance Rewards Scholarship (NJ STARS) program for community college students, and the passage of legislation that provides in-county tuition for undocumented students.

The NJCCC gave Mr. Lee a framed resolution, a framed community college lapel pin set and a copy of *New Jersey: Setting the Pace for the 21st Century*, signed by all in attendance.

HUDSON COUNTY COMMUNITY COLLEGE FOUNDATION TO HOLD 17TH ANNUAL 'HOLIDAY EXTRAVAGANZA' ON DECEMBER 4



Hudson Com-County munity College (HCCC) Foundation's 17th Annual "Holiday Extravaganza" gala will take place on Thursday December evening, 4 at 6:00 p.m. at the College's Culinary Conference Center, 161 Newkirk Street in Jersey City. Proceeds from the event - the largest and most festive of all of the Foundation's

fundraisers – will be dedicated to scholarships for deserving students, faculty development programs, and the College's physical expansion.

The theme of this year's event is "Travel back to the beginning \dots 1974," in celebration of the College's 40th Anniversary.

Hudson County Executive Thomas A. DeGise will be honored at the gala in recognition for his steadfast support of Hudson County Community College and its students. Mr. DeGise has been particularly instrumental in supporting the College's physical expansion; since he became the

County Executive in 2002, the College has completed fromthe-ground-up construction of three new facilities – the Culinary Conference Center and Library Building in Jersey City's Journal Square, and the North Hudson Higher Education Center in Union City. In addition, HCCC has renovated several other buildings in the Journal Square area, including 2 Enos Place, 70 Sip Avenue, and One PATH Plaza.

The Foundation "Holiday Extravaganza" features a hospitality hour and gourmet dinner feast prepared by the chefs/instructors of the College's nationally acclaimed Culinary Arts Institute, with service provided by students from the HCCC Culinary Arts/Hospitality Management program.

The Foundation will also hold its "Lucky Odds" raffle that evening. The Grand Prize winner receives 40% of the raffle ticket sales, Second Prize winner receives 6% and Third Prize winner receives 4%. Raffle tickets cost \$50 each; ticket holders need not be present to win.

The Hudson County Community College Foundation is a nonprofit 501 (c) 3 corporation giving tax-exempt status to contributors. Since the Foundation was established in 1997, it has provided over \$1.5 million in scholarships to more than 1,000 students.

What is a Poster Session?

A poster session is a plenary session where each speaker will have space to display their poster as a visual aid to engage the audience in a quick impromptu presentation while addressing specific questions to small groups. HCCC's Second Annual College Service Day Poster Session will take place immediately after lunch in the Philip Johnston Breakout Room (located on the second Floor of the Culinary Conference Center, across the hall from the Scott Ring Room).

Who can participate?

Anyone attending College Service Day who wishes to share a project/program is invited to participate. This is not a judged event; rather, it is an opportunity to share successes, innovations and implications for practice. Any type of project is welcome whether large or small scale, one-time or ongoing. Points to consider:

Ask yourself, "What would I need to know if I were viewing this material for the first time?" and then state that information clearly. Keep it simple. Place major points in the poster and save nonessential but interesting sidelights for informal discussion. A poster is neither a paper nor a slideshow. Use this session as a way to make connections with people, and share your successes and innovations!

Donor Acknowledgement

Thanks to Karen and Rick Fahrenholz for their generous donation in honor Dr. Glen Gabert and Gregory D. Ratcliff in celebration of their marriage.

Thanks to the HCCC Community for donating 500 works of fine art in the last 5 years. Because of your amazing support and generosity, we have a wonderful collection displayed throughout the public areas of the college.

As the year draws to a close, you might enjoy walking around campus to see the new artwork that has been installed this year. Favorite areas include the student artwork and the pop, surrealist and minimalist work from the 1960s on the fifth floor of the new Library Building, the gallery of Edward S. Curtis photogravures on the fourth floor of the Library Building and, in the library itself, work by Jo Baer, William Wegman, Reginald Marsh, Valeri Larko, Mickalene Thomas, Will Barnet, Rockwell Kent, and others on the first floor, and work by Willie Cole, Leonard Baskin, Chakaia Booker, Donald Baechler, and Ibrahim Ahmed on the second floor. We have also heard good reviews of Kimberly Camp's work in the corridor between Buildings C and D at 162 Sip Avenue, and the new Zarovnaya monoprint at 119 Newkirk Street (Building I) on the first floor.

Art fans have also noted the arrival of work by Will Barnet, Demetrio Alfonso, and many other wonderful talents at the North Hudson Higher Education Center. More artwork by the Blue



Chapel nuns has been installed, so if you haven't been upstairs to the seventh floor in a while, go take a look.

Artist News

Carl Andre, a controversial artist whose work will be installed at 2 Enos Place early next year, is having a show, "Carl Andre: Sculpture as Place, 1958-2010" at Dia: Beacon through March 15, 2015. If you've never taken the drive up to Dia: Beacon in Beacon, New York, and you like strange art experiences, this may be worth a road trip one weekend. An old factory, that covered acres of land, has been converted to an enormous minimalist art space. As one critic said, "The art isn't great, but the space is beautiful." Likewise, many critics cannot stand Carl Andre's work. Because it's so minimalist, they often have difficulty seeing it, or seeing it as art. This is the first survey of Andre's work in 36 years, but be prepared to be underwhelmed: Even though 50 of his works are there, he is famous in part for dispensing with a studio and gathering industrial materials such as brick, copper tile or raw timber locally for each show. Andre then made art by sectioning or stacking the materials in geometric patterns on the floor, thereby disrupting every convention of sculpture.

Chuck Close, whose print work *Phil* hangs in the North Hudson library, is the subject of a major print exhibition at the Museum of Contemporary

We are pleased to report the arrival of the 2014 Print Club of New York presentation print, "Here Come Moses," by Faith Ringgold. The Master printers are Curlee Raven Holton and Jase Clark. This was printed with 11 different screens and colors. Ringgold says the work draws from the roles of both the Underground Railroad and the Great Migration in African-American history. In addition, Jones Road references her own home in New Jersey. Please look for installation of this work and work by Curlee Raven Holton next year.

Art Australia, "Chuck Close: Prints, Process and Collaboration," through March 2015. The show focuses on the artist's prints, including etchings, lithographs, silkscreens and woodcuts. There are wonderful ways to find out more about Close, simply by using your smartphone: If you like Close's work, you might enjoy this YouTube video where he discusses how he uses grids to create his signature work. https://www.youtube.com/watch?v=_e-p5M0vhZI

Marcel Duchamp, a renowned surrealist artist, designed a work of art which was recently installed on the fifth floor of the new Library Building. Duchamp is famous in part for taking a readymade urinal and calling it "art." Now, evidence is emerging that he "stole" this work from a woman poet. According to a recent report in The Art Newspaper, "The Moderna Museet, Stockholm, the San Francisco Museum of Modern Art. Tate Modern, the National Gallery of Canada, the National Museum of Modern Art, Kyoto, Indiana University Art Museum, Bloomington, the Centre Pompidou, Paris and the Israel Museum should all re-label their copies of Fountain as 'a replica, appropriated by Marcel Duchamp (1887-1968), of an original by Baroness Elsa von Freytag-Loringhoven (1874-1927)."

David Beck, whose work is in the North Hudson library, will be part of an exhibition at Washington, D.C.'s Smithsonian Institution, "The Singing and the Silence: Birds in Contemporary Art," through February 22, 2015. He is also the subject of a new documentary, "Curious Worlds: The Art and Imagination of David Beck," which will be released this year. Gordon Parks, whose work Place de la Concorde is on exhibit on the 4th floor lobby of 70 Sip Avenue, is being celebrated in a new exhibition called "Gordon Parks: Segregation Story" at the High Museum in Atlanta, Georgia through June 2015. This exhibition showcases more than forty color photographs by the trailblazing African American artist, many on view for the first time. Created for an influential 1950s Life magazine article, these photographs offer a powerful look at the daily life and struggles of a multigenerational family living in segregated Alabama. Hudson County Community College ha implementado Connect-ED, un sistema de alerta de emergencias, de texto y voz, en caso de una crisis o emergencia, que posea un inmediato y eminente peligro a la comunidad universitaria.

Phil Cafasso, Professor, Culinary Arts and Humanities

Having earned a bachelor's degree in English from Kean

University (formerly Kean College of New Jersey), Professor Cafasso set out on a career in newspapers and then public relations. "I didn't love what I was doing," he said. A relative was working at Hudson County Community College and she told Phil about the renowned culinary arts program in Jersey City, knowing how much he enjoyed food and everything about it. "Ileft my job in PR and came to culinary school at Hudson. I looked at the Culinary Institute of America, but it was very, very expensive. Best choice I ever made. I loved it."

Phil comes from a family in which he was part of the first generation of college students. He dove into HCCC's program and graduated summa cum laude. After culinary school, he landed a job at New York's famous Rainbow Room in the garde manger (cold foods) area of the kitchen. After his long shifts in one of New York's busiest restaurants, he occasionally came by the culinary program to visit with Ernie Staltari, the former Director of the culinary program. During one of his visits, Mr. Staltari asked him if he would be interested in teaching a sanitation course since one of the adjunct chef instructors had left HCCC on short notice. Phil agreed and was on the path towards becoming an instructor in our award-winning Culinary Arts Institute. The offer of a table service class exposed him to another dimension of teaching. With Siroun Meguerditchian's assistance he learned the ins and outs of teaching table service and eventually accepted a full-time post. For 19 years, Phil taught table service to aspiring chefs and restaurant workers. He earned tenure in 1993.

Phil has always been deeply interested in food worlds and the myriad cultural issues attached to food. He is an obsessive reader and was profoundly affected by Reay Tannahill's important book,

Food in History. "The whole idea of looking at the world through food, of thinking about why we eat as we do, this fascinated me," he said. With Elaine Foster's support, he developed a course in Food and Culture and has been teaching it concurrently with culinary arts. By this time, he had earned a master's degree in Hospitality Management from Fairleigh Dickinson University with a specialty in the history of food, restaurants, and the guild systems around chef positions. The HCCC course has become very popular with students and usually fills five sections in a semester. Phil aspires to create an honors section of the course.

For a short while, in the interregnum between Siroun Meguerditchian and Dennis Baumeyer, he supervised the culinary arts program. "I manned the phones and moved the registration process forward. It was a busy time." In the fall of 2014, he stepped into an interim role as Associate Dean of Social Sciences. "I was surprised to hear faculty members telling me what a great job I was doing. Our division meetings have been productive and I've been glad to be able to serve the institution in a time of need." As Associate Dean, he has been setting the agenda for the division meetings, hiring and scheduling adjunct instructors, participating in interviewing candidates for the 12-month history position, and solving a host of student issues including plagiarism and student conflicts with instructors. In the spring, he will return to teaching with some administrative duties.

"The culinary faculty has stayed intact over the years, and there's a tremendous esprit de corps in our division," Phil states. "When I walk over to the culinary building, I have a tremendous sense of coming home." He continues to read voraciously and has included Michael Pollan's works in his courses, especially *The Omnivore's Dilemma*. "I love Stephen King's work as well and highly recommend 11/22/63, one of his recent books."



Mercy Martinez, Clerk, Bursar's Office

Mercy Martinez has been a team member in the Bursar's office for three decades. Her

first job at Hudson County Community College was in the HR department. where she worked for six months. She started taking Computer Science classes at HCCC in 1982 and gained foundational experience in the workstudy program assisting the Bursar. "They were the very first computers; everything was done manually," she reflected. "We ran reports by hand and checked one by one to make sure all of the amounts were correct."

Mercy was an only child and came to Florida from Cuba when she was 18 years old. She has a deep understanding of the hard work it takes to nurture and support a family. She got married and had children, eventually moving to New Jersey with her parents. "When I was in Cuba," she said, "I didn't want to continue on in school but I needed to. I stayed through high school and into a preparation school. It was a hard time there; both of my parents worked to make sure I had what I needed." She laughed when she said that after moving to New Jersey and enrolling at HCCC, she found herself doing homework at the same time that her daughter was doing homework.

On a typical work day, Mercy interacts with students as they make their payments and negotiate the processes of financial aid. She processes stop-payments when checks are lost and manages chargebacks for students who live out of county. Third-party billing falls under her umbrella as well.

The College has become a success, she stated, and "it has become a place that helps students who move on to other colleges." Sometimes, students whom she has assisted come back to let her know how they are doing. "They come to say hello and students from Culinary Arts come to tell me about the restaurants they work in, the jobs they have, and even the restaurants they own. It's nice to see them successful."

Once in a while, Mercy encounters a student who wants to challenge an aspect of the chargeback process. "They want to fight sometimes but I explain things clearly. It can be confusing for them. The one-on-one approach works. Then they say they're sorry."

When Mercy started working at HCCC in the eighties, the College only owned one building. Today, we serve over 9,000 students in credit-bearing programs and thousands in non-credit classes. "I work with people who are nice and I get to see students that come here and they finish with us and then they go on and graduate from the next college. It's nice to see."





HUDSON COUNTY COMMUNITY COLLEGE FOCUS GOALS - 2015

nnually, the Board of Trustees, in consultation with members of the staff and community, identifies and defines institutional priorities in the form of "focus goals". The following goals are established for the period ending December 31, 2015.

- 1. Several areas within the College have developed effective strategic plans. This was acknowledged by the Middle States Association in conjunction with the Periodic Review Process. At the same time it was determined that there is a need to better coordinate these separate plans and develop one comprehensive and long range strategic plan for the College with the assistance of an external consultant. The final plan should include projections for five years and include processes and procedures for ongoing evaluation and updating. At least these elements should be reflected in the final plan:
- a. A statistically based and aggressive enrollment management plan that reflects the current environment and opportunities afforded by ongoing campus development.
- b. A comprehensive plan for student success,

reflecting national trends and the work done by the New Jersey Council of County Colleges and building on the platform and component programs already in place, with measurable goals and timetables.

- c. A plan for the expansion of community education that would include: making maximum use of the programming platform provided by the College Art Collection; a feasibility study for the establishment of a local history center on campus; and the promotion and expansion of the College's role as a nexus for public service programming.
- d. A business plan for online instruction including facilities needs, budgets, staffing and programming.
- e. An updated and comprehensive marketing plan that would not only reflect credit enrollment management, but also non-credit programming, community services, institutional image and brand.
- f. An updated facilities master plan compatible with the College's strategic plan and complying with documentation requirements for Chapter 12 funding eligibility.

- 2. The North Hudson Higher Education Center is currently designated as an "attendance center" by the Middle States Association. The College should pursue branch campus designation by the Middle States Association for the North Hudson Higher Education Center by filing a substantive change application by the established deadline thereby permitting complete degree programs to be offered in Union City.
- 3. The College has become a complex business operation, and HCCC should develop and implement updated policies and procedures to centralize contract management, purchasing and accounts payable/receivable services.
- 4. Funding has been secured from the County and State for a new science, technology, engineering and math (STEM) facility in Journal Square. The College should complete planning and development for a new STEM facility and begin construction.

TESTING SCHEDULE

all new students are required to take the CPT, which allows for course placement that is appropriate to their skill level. We have created a walk-in schedule to give students the opportunity to Study/Review their Math and English skills prior to visiting the Testing Center.

It is extremely important that you take the College Placement Test seriously. Depending on your score, you may have to register for and pay to take additional semesters of courses that do not bear college credit or/count toward graduation.

Before Taking the CPT:

- a. Students must submit an Application to Admissions (70 Sip Ave.).
- b. To review for the College (College Board's "Accuplacer"), please visit: www.collegeboard. com/student/testing/accuplacer/
- c. For CPT exemption criteria such as SAT scores and applied transfer credit for English and/or Mathematics, visit: www.hccc.edu/testing

On the day of the CPT students must:

- a. Report at least 10 minutes before the test start time.
- b. Bring photo ID (Driver's License / Passport / Green Card / Student ID).
- c. Have your College Wide ID number.
- d. Bring a copy of transcripts (only if student is a transfer or foreign student).







- 5. Funding has been identified to relocate and enlarge the College Book store at 162 Sip. This project should be completed.
- 6. Funding has been identified for an expanded and improved area to be used for tutoring and other academic support functions. The College should complete and open the Abegail Douglas-Johnson Academic Support Center in the Library Building.
- 7. The College currently supports strong programming in allied health. The College should develop and enter into partnerships with CarePoint Hospital and Saint Peter's University to expand and strengthen existing programs.
- 8. Funding has been identified to develop laboratory and teaching space on the Journal Square Campus for strengthened allied health programs. The College should develop and complete plans to modify the Joseph Cundari Building into a state-of-the-art allied health facility.
- 9. Allied health and STEM are projected growth areas. Initiate a two-year planning and development process for allied health and STEM programs that would not only reflect the opportunities afforded by the new science building but also changes that are occurring in allied health education and the delivery of health services in the County.
- 10. The College's programs and services related to career counseling are decentralized. HCCC should establish a career development center with an appropriate business plan.
