**STATE OF NEW JERSEY  
IMMUNIZATION REQUIREMENTS FOR ADMISSION**

Hudson County Community College, as mandated by the State of New Jersey (N.J.A.C. 8:57-6.3, 6.4, 6.5 and 6.6), is required to have on file, proof that all **full-time students** must have been immunized against certain preventable diseases, i.e. **Measles, Mumps and Rubella (MMR)** and also **Hepatitis B** or provide evidence that they are exempt. In addition, **ALL** full-time students at HCCC **MUST** provide proof (in addition to the above listed immunizations) of a Booster Measles Shot.

Students who are in partial compliance will be permitted to register on a provisional basis for his or her first term if the required immunization documentation is not available at the time of registration. Prior to registration for the second term, a student shall either present documentation of immunization, proof of immunity or be re-immunized. Students who are not in compliance within this time frame may be de-registered.

The following documents are acceptable as evidence of immunization and the date it was administered:

1. Official School Immunization Record
2. A record from any public health department – with official physician’s stamp
3. HCCC’s College Immunization Affidavit Record form signed by a physician

A student shall be exempt from immunization requirements for medical or religious reasons, provided that he or she meets the criteria as set forth at N.J.A.C. 8:57-6.11 and 8:57-6.12, respectively.

In addition, an exemption may be made, at the discretion of the institution, for the following categories of students (**Exempt students must meet ONE of the following conditions**):

- **Medical reasons (for example, pregnancy). A physician’s statement must be submitted.**
- **Religious Reasons. A statement signed by an official of the religious organization must be submitted.**
- **Born before January 1, 1957 – Does not apply to the Hepatitis B vaccination**
